RhodeMap RI Great Places Workshops

Join RhodeMap RI for the second round of Great Places workshops in October across the state.

The purpose of the five public workshops is to get input from the public as well as municipal officials and staff on existing and potential future growth centers. Participants in the meetings will have an opportunity to discuss and review maps showing green assets, such as water and agriculture, and economic and social assets such as roads, job centers, and cultural sites. We need your help in determining if the maps are accurate and complete.

Additional workshops in November and January will start discussions on the implications of this mapping: where and how should we grow? What can the state do to reform regulations or provide incentives to support growth centers?

From the R.I. Historical Preservation & Heritage Commission Certified Local Government grant applications available

Each year the Rhode Island Historical Preservation and Heritage Commission awards federal 50 percent matching grants to local governments whose municipal historic preservation program has been certified by the Commission. Currently, seventeen communities are eligible to apply for CLG grants: Bristol, Cranston, Cumberland, East Greenwich, East Providence, Glocester, Hopkinton, Narragansett, New Shoreham, Newport, North Kingstown, North Providence, North Smithfield, Pawtucket, Providence, South Kingstown, and Warwick. The Commission will continue to give highest priority to projects which address important preservation needs within the applicant community or to a statewide preservation need. Municipal Training Offered Rhode Island Community Profiles Training

Rhode Island Community Profiles is a set of comprehensive maps and data on neighborhoods across Rhode Island. Find data on race, income, housing, transportation, employment, education, and more. RI Community Profiles was developed by The Providence Plan Information Group which provides Rhode Islanders and state agencies with data and information to support critical decision making.

This workshop is designed for municipal planning staff and others who need to access data for comprehensive planning or grant proposals. You will learn to navigate the site including some hands-on exercises, margin of error issues, RI data quirks, and how data is collected. There will also be some additional data hunt exercises using typical comprehensive plan information retrieval and the use of the search function and the data displays. At the end there will be time for discussion and feedback about how Community Profiles can be made even more useful for planners.

Why Economic Developers Should Care About Transportation October 3, 2013, 3:30 to 4:30 PM

This is the first of three Transportation Webinars for Economic Developers, focusing on "why economic developers should care about transportation."

Transportation initiatives at the local, state and federal level affect local and regional competitiveness and economic development. Hear how investments in transportation improvements have bolstered economic growth and performance. Transportation improvements can be catalysts for expanding access to labor markets, multi-modal freight movement (including by truck, rail, sea and air) and logistics sector development, as well as more localized real estate and tax impacts associated with transit oriented development. Hear best practices in the Northeast and nationally from top speakers:

Richard A. Dimino, President & CEO, A Better City (ABC), Boston MA

Mr. Dimino has served as the President and CEO of A Better City (ABC) since 1995. Under his leadership ABC has achieved major accomplishments such as helping to keep Boston open for business during the construction of one of the country's most complex highway projects. In addition, he significantly influenced the planning, design and development of a twenty-seven acre corridor along Boston's waterfront and successfully launched ABC's Sustainability and Climate Change Initiative. Through Mr. Dimino's guidance, ABC recently played a key role in shaping Massachusetts' Transportation Reform Legislation which led to the launching of the new Massachusetts Department of Transportation (MassDOT). ABC was also an integral part of a coalition that recently secured significant new statewide transportation revenue. Prior to his time with A Better City, Mr. Dimino served as the Vice President and Deputy Manager of Stone & Webster Engineering Corporation's Transportation Business Sector. This position followed nearly a decade of service as Boston's Commissioner of Transportation where Mr. Dimino oversaw a 400-plus member department that developed and implemented all transportation policies and projects for the City. Mr. Dimino received his Master's in Business Administration from Boston University, is a graduate of Northeastern University and completed a Loeb Fellowship at Harvard University's Graduate School of Design.

Julie L. Lorenz, Sr. Strategic Consultant, Burns & McDonnell, Kansas City MO

Julie Lorenz, Sr. Strategic Consultant, leads Burns & McDonnell's strategic consulting and public engagement services for the transportation practice based on more than 20 years of experience in communication, public affairs and policy development in the transportation industry. Most recently, she served as Director of Public Affairs at the Kansas Department of Transportation (KDOT), where she led strategic planning and integrated collaboration/communication efforts. Notably, KDOT secured an \$8.2 billion 10-year funding program in spring 2010, resulting largely from stakeholder collaboration and a focus on economic impact analysis. She is recognized as a national leader in areas of facilitation, collaboration and communicating economic analysis.

Costa Pappis, AICP, Policy & Planning Division, Vermont Agency of Transportation, Montpelier VT

Costa Pappis, Planning Coordinator, is a modal planner for the Vermont Agency of Transportation, specializing in highway, rail, and freight planning. He is responsible for managing the agency's major planning studies and coordinating planning activities regionally and with partners in Canada. He works closely with federal agencies and industry groups such as railroads and trucking companies. In the past few years, he worked on interstate weight limits policy, national transportation funding issues, and the rehabilitation of a major New England regional rail corridor. Mr. Pappis received his Master of Urban Planning from McGill University and a Master of Science Degree in Administration from California State University. He is also a member of the American Institute of Certified Planners.

New Releases: 2012 American Community Survey Estimates; 2012 Current Population Survey Report: *Income, Poverty and Health Insurance Coverage in the United States:2012*

On September 19, the U.S. Census Bureau released the 2012 one-year American Community Survey (ACS) estimates. One-year ACS estimates are available for geographies with populations greater than 65,000, and describe the social, economic, and housing characteristics of people and places. These data can be downloaded from American FactFinder at <http://factfinder2.census.gov/> (to find the new data, select *Advanced Search*, and then *Topics > Dataset > 2012 ACS 1-year estimate*). Additionally, the ACS published three new data briefs: [Household Income :2012](#), [Poverty: 2000-2012](#), and [Mitigating the Loss of Private Insurance With Public Coverage for the Under-65 Population: 2008-2012](#).

Also, on September 17th, The Report: *Income, Poverty and Health Insurance Coverage in the United States:2012* was released and presents data based on information collected in the 2013 and earlier Current Population Survey (CPS) Annual Social and Economic Supplements (CPS ASEC) conducted by the U.S. Census Bureau. The report, which is based on a sample of approximately 100,000 addresses focuses on national calendar-year estimates of income and official poverty numbers and rates along with other demographic and social characteristics. A general rule of thumb when using poverty and income estimates from the Census Bureau on when to use each survey is when looking at national estimates one should use the CPS, when looking at state or local level data or to compare states with each other, it recommended one use the ACS estimates. The differences between the CPS and ACS range from sample size, length and detail of questions, and reference period.
