2015-2016 LOBSTER TRAP TAG ORDER FORM INSTRUCTIONS

PLEASE NOTE THAT THESE INSTRUCTIONS HAVE BEEN MODIFIED AND THERE IS A NEW VENDOR PRODUCING THE TAGS

To reduce the likelihood of a delay in received your tags, please place your order as soon as possible. Allow for a minimum of eight (8) weeks delivery time.

The Department assumes no responsibility for tags not received in the desired time. **All traps in the water beginning June 1, 2015 must have new tags properly attached.**

1. The vendor for lobster trap tags is **Cambridge Security Seals, LLC**. Send completed order form to the following address*:

*** A duplicate copy of the application is no longer required to be sent to the Division of Fish and Wildlife. A single form is to be sent to the vendor at the address provided above.**

2. The number of tags ordered must not exceed allocation. **Any changes to allocation, contact information, address, vessel name, new vessel or permit(s), etc. must be made by contacting the Division of Fish and Wildlife, Marine Fisheries office prior to submitting your order form to the vendor.** Order forms that do not contain accurate up-to-date information **will not be processed**, and may be returned to the fisherman for corrections. Please contact the Division if you are unsure of your allocation.
3. Fill out all sections of the order form completely. **Incomplete order forms will not be processed and may be returned to the fisherman for corrections.**
4. **RI Commercial Fishing License:** Enter your Rhode Island commercial fishing license number (not your Pot number). **NOTE:** License numbers begin with a series of letters (MPURP, PEL, or

CFL) followed by a series of six numbers (for example: MPURP000123; PEL000123; CFL 000123; RESLND000123; NRLNDR000123; NRLAND000123). **All trap tag orders are assigned to a commercial fishing license. Failure to identify the correct commercial fishing license may result in your application being returned.**

5. **Vessel Name:** Enter your vessel's official name. If not named, please write "unnamed."
6. **RI Boat Registration or Federal Documentation Number:** Enter your vessel's Rhode Island boat registration number (hull identification number) or Federal Vessel Documentation number. **All trap tag orders MUST include a properly licensed or documented fishing vessel.**
7. **Federal Lobster Permit Holders Only:**
 - Identify the Federal Lobster Permit Number assigned to the vessel;
 - **Declaration of Lobster Management Area(s):** LMAs declared to the State of RI must be identical to the LMAs identified on your NOAA Fisheries Federal Lobster Permit. If multiple LMAs are declared, the maximum number of tags ordered must be based on the lowest LMA trap allocation assigned to the permit. (Note: For the purposes of your trap tag order, the Area 2/3 overlap is allowed with declaration of either LMA 2 or LMA 3.)
8. **PAYMENT INFORMATION:** Certified checks, money orders, and credit cards will be accepted as payment. Personal or business checks will not be accepted.
9. **Division of Taxation Exemption Certificate:** Complete this form only if not paying the 7% RI sales tax. Include 7% sales tax on your order form if not completing this form.
10. **TRAP TAG ORDER:**
 - **Original Trap Tags:** This is your allocation of trap tags. You may order your allocation and an additional 10% for routine losses (e.g., allocation = 800 tags; total order of original tags not to exceed 880 tags).
 - **Gear Rotation Trap Tags:** If you plan to rotate gear during the year, you may pre-order Gear Rotation trap tags, up to the number of traps allocated, but not including the additional 10% for routine losses. Gear Rotation trap tags will be held by the issuing authority (Division of Fish and Wildlife) and may be obtained on a one-for-one exchange basis with current original trap tags. These tags are optional.
 - **Catastrophic Loss Trap Tags:** You may pre-order a complete duplicate set of trap tags to be used in the event of catastrophic gear loss. **The number of catastrophic tags ordered must be equal to the number of original tags ordered (not including the additional 10% for routine losses, if ordered).** Catastrophic Loss Trap Tags are distinguishable from original trap tags (i.e. different color). Pre-ordered Catastrophic Loss Trap Tags shall be held by the issuing authority. These tags are optional. **Notification to the DEM's Division of Law Enforcement will occur upon the issuance of Catastrophic Loss Trap Tags. Issuance of Catastrophic Loss Trap Tags shall null and void all original and gear rotation trap tags.**
