2018-2019 GILLNET TAG ORDER FORM INSTRUCTIONS

- 1. To reduce the likelihood of a delay in received your tags, please place your order as soon as possible. Allow for up to four (4) weeks delivery time.
- 2. Each license holder may order up to 90 tags. Any changes to contact information, address, vessel name, new vessel or permit(s), etc. must be made by contacting the Marine Fisheries office prior to submitting your order form to the vendor. Order forms that do not contain accurate up-to-date information will not be processed, and may be returned to the fisherman for corrections. Please contact the Division if you are unsure of your allocation.
- 3. The Department assumes no responsibility for tags not received in the desired time. Please contact the Division if you are unsure of your authorized allocation or to report any changes from the previous year's information. Incomplete order forms will not be processed and may be returned to the fisherman for corrections. All gillnets in the water beginning April 1, 2018 must have new tags properly attached.
- 4. <u>**Division of Taxation Exemption Certificate:**</u> Complete this form if exempt from paying the 7% RI sales tax.
- 5. <u>Original Tag Orders</u>: Fill out the attached form and circle "original", indicating this is an original order. Upon approval, you will be issued sequentially numbered tags assigned exclusively to you.
- 6. **<u>Replacement Tag Orders:</u>** In the event of a catastrophic loss of tags, replacement tags may be ordered. Fill out the attached form and circle "replacement" indicating this is a replacement order. You must turn in any remaining tags to Marine Fisheries prior to replacement tags being issued. Upon approval, you will be issued sequentially numbered tags with new numbers assigned exclusively to you.
