

Self-reported effects of the COVID-19 pandemic on stewardship organizations and their activities in southeast New England, USA

The <u>Stewardship Mapping and Assessment Project (Stewmap)</u> of Southern New England is a survey and public database designed to map where stewardship organizations work and how they are connected to each other with the goal of strengthening community capacity of stewardship in the SNEP region. Using the sample drawn from the initial outreach and first two rounds of alter surveys for the Stewmap project, the team successfully published on Frontiers online journal. To date, the planning board adopted amendments to the Conservation Development Zoning Ordinance at a public hearing on January 19th.
